I refer to your letter of 23 October 2014 regarding the renewal of determinations held by Virgin Australia International Airlines Pty Ltd (Virgin Australia) for the Bangladesh, France, Thailand and United Arab Emirates routes which are due to expire within the next 12 months.

Determination [2010] IASC 122 (Bangladesh)

Virgin Australia continues to fully utilise capacity allocated by Determination [2010] IASC 122, as varied by [2011] IASC R03, [2011] IASC R10, [2011] IASC R12, [2012] IASC 211 and [2013] IASC R01, to offer code share services to Bangladesh on flights operated by Singapore Airlines. We wish to retain this allocation and therefore seek renewal of the abovementioned determination for a period of five years from 25 October 2015.

Determination [2010] IASC 120 (France)

Virgin Australia offers code share services to France on flights operated by both Etihad Airways and Singapore Airlines, utilising capacity allocated by Determination [2010] IASC 120, as varied by [2011] IASC R04, [2011] IASC R10, [2012] IASC 217 and [2014] IASC R01. Our code share services on this route continue to develop and our capacity utilisation has been variable. We expect our utilisation to grow in the coming seasons and therefore wish to retain our full allocation of capacity. Accordingly, we seek renewal of the abovementioned determination for a period of five years from 25 October 2015.

Determination [2010] IASC 119 (Thailand)

Virgin Australia continues to fully utilise capacity allocated by Determination [2010] IASC 119, as varied by [2011] IASC R05, [2011] IASC R10, [2011] IASC R14, [2012] IASC 213 and [2014] IASC R01, to offer code share services to Thailand on flights operated by Singapore Airlines and SilkAir. We wish to retain this allocation and therefore seek renewal of the abovementioned determination for a period of five years from 25 October 2015.

Determination [2010] IASC 118 (United Arab Emirates)

Virgin Australia continues to fully utilise capacity allocated by Determination [2010] IASC 118, as varied by [2011] IASC R10, [2013] IASC 215 and [2014] IASC R01, to operate our services to the United Arab Emirates. We wish to retain this allocation and therefore seek renewal of the abovementioned determination for a period of five years from 25 October 2015.
