Request to transfer capacity allocations to Virgin Australia International Airlines Pty Ltd

The Virgin Australia Group is seeking to vary the determinations supporting a number of our short-haul international routes, as part of streamlining the economic regulatory arrangements underpinning our international operations.

Variations sought

The Virgin Australia Group requests a variation to each of the following determinations to transfer to Virgin Australia International Airlines Pty Ltd (VAIA) the capacity currently allocated to Virgin Australia Airlines (SE Asia) Pty Ltd (VAASEA), with effect from 1 October 2018. We also request that each capacity allocation is varied to authorise the utilisation of such capacity by another Australian carrier which is a wholly-owned subsidiary of VAIA, namely Tiger International Number1 Pty Ltd. A complete list of the determinations in respect of which this variation is sought is provided below:

VAASEA continues to operate services to the Solomon Islands utilising capacity allocated under Determination [2013] IASC 133, which is due to expire on 8 July 2019. In conjunction with our request for variation of this determination to effect a transfer of the capacity to VAIA, we also wish to seek its renewal for a period of five years from 9 July 2019. We request that this renewal is granted subject to all existing conditions contained in the current determination.
