### RENEWAL DETERMINATION

## 1 The application for renewal

- 1.1 On 29 August 2003, the Commission issued an interim Determination [2003] IASC 114 (the Determination) allocating 60 tonnes of freight capacity per week to HeavyLift on the Papua New Guinea (PNG) route.
- 1.2 Under the *International Air Services Commission Act 1992* (the Act) the Commission must start its consideration of the renewal of a determination at least 12 months before the expiry of the determination. The Determination expires on 28 August 2006.
- 1.3 HeavyLift applied to the Commission for a renewal of the Determination. The Commission published a notice on 6 September 2005 inviting submissions or other applications for an allocation of the capacity subject to renewal. No submissions or other applications were received.
- 1.4 All material supplied by the applicant is filed on the Register of Public Documents.

#### 2 Commission's consideration

- 2.1 Under the Minister's Policy Statement (No. 5), of 19 May 2004, where capacity is limited under a bilateral arrangement, the relevant criteria are set out in paragraph 8.2. On routes where the start up phase is over, as is the case on the PNG route in relation to separate freight capacity, the applicable criteria are those set out in paragraphs 4 and 5.
- As there were no other applicants for the capacity, the criteria in paragraph 5 are considered by the Commission to be not relevant in this case. Under paragraph 4, the use of entitlements by an Australian carrier that is reasonably capable of obtaining

the necessary approvals and of implementing its proposals is of benefit to the public. The Commission considers that HeavyLift is now an established international carrier and satisfies the paragraph 4 criteria. This means that there is public benefit arising from the use of the entitlements. In these circumstances, the Commission concludes that the renewal of Determination [2003] IASC 114 would be of benefit to the public.

2.3 The wording of the fresh determination below reflects the view of the Commission that determinations which renew original determinations should contain updated terms and conditions consistent with the Commission's current practice and current air services arrangements. Under the Act, the Commission may make changes to the terms and conditions included in the original determination where warranted by changes in circumstances since the original determination was made.

# Determination for renewal of Determination [2003] IASC 114 allocating capacity on the Papua New Guinea route to HeavyLift ([2005] IASC 114)

- 3.1 The Commission makes a determination in favour of HeavyLift, allocating 60 tonnes of freight capacity per week in each direction on the Australia Papua New Guinea route, in accordance with the Australia Papua New Guinea air services arrangements.
- 3.2 The determination is for five years from 29 August 2006.
- 3.3 The determination is subject to the following conditions:
  - HeavyLift is required to fully utilise the capacity;
  - only HeavyLift is permitted to utilise the capacity;
  - HeavyLift is not permitted to utilise the capacity to provide services jointly with another Australian carrier or any other person without the approval of the Commission;
  - changes in relation to the ownership and control of HeavyLift are permitted except to the extent that any change:
    - results in the designation of the airline as an Australian carrier under the Australia – Papua New Guinea air services arrangements being withdrawn; or
    - has the effect that another Australian carrier, or a person (or group of persons) having substantial ownership or effective control of another Australian carrier, would take substantial ownership of HeavyLift or be in a position to exercise effective control of HeavyLift, without the prior consent of the Commission; and

 changes in relation to the management, status or location of operations and head office of HeavyLift are permitted except to the extent that any change would result in the airline ceasing to be an airline designated by the Australian Government for the purposes of the Australia – Papua New Guinea air services arrangements.
