I refer to your letter of 7 November 2016 in relation to the renewal of determinations held by Virgin Australia on the Fiji and Solomon Islands routes, both of which are due to expire in 2017.

Determination [2011] IASC 131 (Fiji)

Virgin Australia continues to fully utilise the capacity allocated by Determination [2011] IASC 131 (issued in favour of Pacific Blue Airlines (Aust) Pty Ltd) to operate our services to Fiji. We wish to apply for renewal of this allocation of capacity for a period of five years from 5 November 2017, subject to existing conditions.

As you are aware, Pacific Blue Airlines (Aust) Pty Ltd changed its name to Virgin Australia Airlines (SE Asia) Pty Ltd on 7 December 2011 (please refer to **enclosed** documentation issued by the Australian Securities and Investments Commission). We request that the renewed determination reflects this change of name.

Determination [2011] IASC 115 (Solomon Islands)

Virgin Australia currently utilises 352 seats per week for the operation of our flights to the Solomon Islands. We wish to apply for renewal of all 360 seats of capacity allocated under Determination [2011] IASC 115 (as varied by [2016] IASC 203) in favour of Virgin Australia Airlines (SE Asia) Pty Ltd for a period of five years from 10 December 2017, subject to existing conditions.
