### APPLICATION FOR VARIATION – INDONESIA ROUTE

As part of a code share arrangement between Qantas Airways Limited (Qantas) and PT Garuda Indonesia (Persero) Tbk (Garuda Indonesia), it is proposed that Garuda Indonesia offer code share services on flights operated by Qantas on the Indonesia route from 29 October 2023, or as soon as all necessary approvals have been received.

The code share arrangements expand the number and timing of services that may be marketed and independently priced by Garuda Indonesia to/from Australia, providing additional options and choice for consumers. A summary of the options available in Northern Winter 2023 are set out in the table below.
